



*JNCC has responsibility for the provision of nature conservation advice for UK waters beyond 12 nautical miles offshore. Within JNCC, the Marine Management team provides nature conservation advice to regulators, industry, statutory nature conservation bodies and a range of other stakeholders. Part of this advice is the provision of a 24hr pollution response advice service.*

## Experience

- As a core member of the Environment Group (EG) (under the UK Government's National Contingency Plan (NCP)), we have experience in taking part in, and responding to, a number of real incidents and Secretary of States' Representative for Maritime and Salvage (SOSREP) exercises, in which operators are required to test their Oil Pollution Emergency Plans (OPEPs).
- This includes incidents involving shipping and offshore hydrocarbon installations.
- Taking part in NCP and SoSRep exercises (Including *Exercise Dragon*, *Grey Seal* and *Shen*).
- We have been developing and applying guidance and tools to pollution incidents and exercises which have subsequently been taken on board by UK EG Chairs.
- We work within our UK co-ordination remit to ensure consistency and join-up of central government responders and we co-ordinate the Marine Industry Groups Pollution meetings.
- We sat on the steering group for the development of the Seabird Oil Sensitivity Index (SOSI), and subsequently developed guidance for its application in contingency planning and incident response.
- We also sit on the Premium post-spill marine impact assessment and monitoring steering group.

## Core competencies

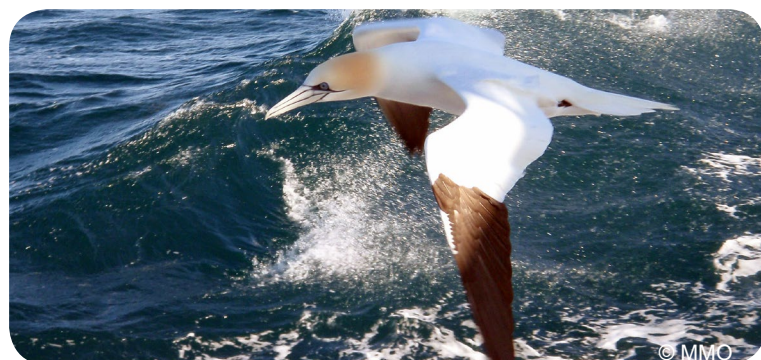
We have a team of six staff who are experienced in incident exercise/response and are trained in:

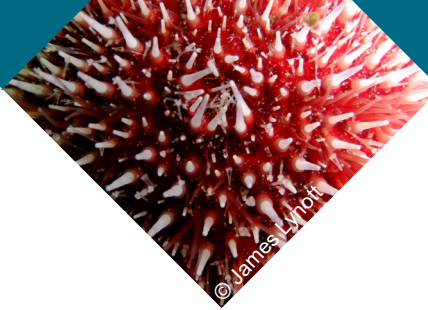
- DECC Level 2 Oil Spill Response.
