1. Closed session

- 2.1. Professor Galbraith welcomed members and attendees to the 135th meeting.
- 2.2 Professor Galbraith reminded members that this was his last meeting as Chair of JNCC. Further information about the plan for succession will be confirmed as information becomes available.
- 2.3 Professor Galbraith expressed his thanks to the Chairs and CEOs of the SNCBs for their input into the meeting on 6th June.

3. Declaration of interests

3.1. No additional declarations were made. Members were reminded of the need to keep their declarations up to date and to advise the Governance team of any new declarations as soon as they occur.

4. Confidential minutes of the March 2023 Meeting (Official-sensitive) (JNCC 23 20D)

4.1 This item was taken in confidence.

5. Matters arising (Official) (JNCC 23 21P)

- 5.1. There were no matters arising for this meeting.
- 5.2. Professor Ormerod requested JNCC liaise with Natural Resources Wales regarding the planned ARAC meeting in Bangor in November 2023 and Joint Committee meeting in Cardiff in March 2024.
- 5.3. Professor Austen requested that AP12 from the March 2022 meeting be closed as this has been superseded by AP01 from the March 2023 meeting.
- 5.4. Members **noted** the paper and confirmed they were content with the progress

made on outstanding actions to date.

Action point(s)

AP01 Governance Team to liaise with NRW regarding the planned ARAC meeting in Bangor in November 2023 and Joint Committee meeting in Cardiff in March 2024.

AP02 Governance Team to amend action point table to show that AP12 from the March 2022 meeting has been superseded by AP01 from the March 2023 meeting.

6. CEO report (Official-sensitive) (JNCC 23 22P)

6.1 This item was taken in confidence.

Report from Chief Scientists Group (Official) (JNCC 23 22P)

- 7.1 The item was introduced by Professor Stone who commented on the change in the work of CSG from a reactive to a proactive approach. This has been particularly reflected in recent workshops. The workshops have identified opportunities for JNCC along with opportunities for collaboration.
- 7.2 CSG have discussed recruitment and career paths within the sector and challenges that are being faced. A collective supportive approach between the SNCBs has been suggested.
- 7.3 CSG have agreed that an annual horizon planning paper will be provided to the Joint Committee for discussion which will be produced following horizon scanning and forward look discussions at CSG.
- 7.4 Joint Committee members raised the following in relation to the paper:
 - i. Horizon scanning is a 'thing of the moment', with Bill Sutherland's work in ecology cited as an example. CSG were encouraged to take a structured approach to establishment of the future horizon and to select a top 10 to tackle. Horizon landscape analysis could identify areas to develop and feed into UKRI. Horizon scanning should not be completed in isolation it could present an opportunity to work with Research Councils.
 - ii. Members of the Joint Committee offered to assist and contribute to workshops as well as engaging with the academic community. Governance at different levels will form a strong part of implementation.
 - iii. The use of joint appointments with universities was raised as a way to fill vacancies where relevant.
 - iv. JNCC is not currently represented on the UKRI RIDE forum. There is a need to ensure programmes are UK focused and meet needs across the four countries. Dr Harper agreed to follow up on this and continue to develop a relationship into UKRI.

- v. One key area to influence agendas was through thematic programmes and to consider how these address themes. Being involved in development.
- 7.5 Members suggested CSG could provide a steer on how bureaucracy could be reduced to assist in action to tackle the current nature loss crises. Lord Blencathra suggested that JNCC's scientists could play a more public role.
- 7.6 The Committee noted the report from the Chief Scientists Group and welcomed the planned paper on horizon scanning, agreeing that this should become an annual item presented to the Joint Committee. Members welcomed the plan for increased engagement with UKRI.

AP03 Dr Harper to follow up on JNCC inclusion in the UKRI RIDE forum and continue to develop relationship with UKRI.

- 11.3 An update on attendees was provided by Dr McGuckin, with confirmation that work to meet targets for Northern Ireland would be completed by several agencies and not just by NIEA.
- 11.4 The first part of the Joint Committee meeting closed and members were thanked for their contributions.
