## **Executive Summary**

### 1. Action required

- The Joint Committee is asked to:
  - i. **Discuss and agree** the forward programme contained in Annex 1 and suggest any additional items.
  - ii. **Discuss and agree** to suspend large-scale external engagement events linked to Committee meetings until the end of the calendar year and effective stakeholder engagement is reviewed, including how best to utilise board members (Annex 2, table 1).
  - iii. **Discuss and agree** moving the September 2024 meeting from London to Peterborough and reducing the December 2024 online meeting to one day.
  - iv. **Note** the dates and amended locations of Committee meetings for 2024-2025 in Annex 2 (table 2).
  - v. **Note** the importance of Joint Committee meetings to be quorate. Quoracy is one member from each of the statutory nature conservation bodies and two independent members, including the Chair. All in person meetings will have a hybrid option for those unable to attend in person.
